### Special Notices.

- To enter 800 Free a swimmer must have a 400 free time on the data base.**
- To enter the 200 Fly must be 12 years and older and have a level 3 100 Fly qualifying time on the data base.**
- Swimmers needing a 400 Free time may enter the 800 Free on the following conditions.**
  - A concession request be submitted before the entry closing date.
  - To obtain an official 400 Free time they must finish the 800 Free without been DQ.
  - Must supply an additional time keeper for the 800 free to record the 400 time.
- COACHES PLEASE TAKE NOTE OF THE FOLLOWING RULE TO ENTER SSA REGIONAL AND NATIONAL EVENTS.**
  - **Level 2 Regionals: one (1) 200 IM time on the SSA data base.**
  - **Level 3 and Junior Age Group: Two (2) IM times on the SSA data base. Can be a combination of 200 IM and 400 IM.**
  - **If a swimmer is in a position that they cannot swim a Medley due to some sort of injury a concession letter must be submitted in the month of injury as no concession will be granted at Championship entry closing date.**

### Conditions of Entry

- Swimmers must be registered by no later than 16h00, 22 December 2016
- No unregistered swimmers will be allowed to participate in any KZNA sanctioned Gala.
- Only competitive registered swimmers may enter, no level 0 registered swimmers may enter Age Group Galas.
- No Shows are subject to a R50.00 fine. Clubs will be notified and payment of fine to be paid before swimmer may enter the next KZNA scheduled gala.
- Scratchings from the gala will be accepted up to 30 minutes before the start of the gala.

- Corrections will be accepted up to 30 minutes before the start of the gala.
- **SCRATCHINGS WILL ONLY BE ACCEPTED ON A WITHDRAW FORM BY CLUB COACHES OR MANAGERS.**
- Late Entries will be accepted up to 30 minutes before the start of the gala.
  - On condition Lanes are available.
  - Cost at 10 times the original entry fee. (R200.00)

## General Rules

- Gala will be swum in accordance with FINA, SSA and KZNA Rules.
- The one start rule will be applied.
- Objections must be submitted in writing up to 30 minutes after the event.
  - An R300.00 fee to be paid with submission of Objections.
  - Referee and Tournament Committee decision will be final.
- KZNA Swim Board reserve the right to cancel or postpone the gala should there be;
  - Insufficient entries.
  - Reasons beyond their control.
- All Age Group Galas will be captured and recorded on the KZN data base and SSA data base.
- Swimmers age is determined by their age on the day of the gala.
- Referee has the right to consolidate heats as deemed fit.
- Referee has the right to change event sequence if conditions demand.

## Gala Entries

- Gala entries to be e-mailed to [admin@kznaquatics.co.za](mailto:admin@kznaquatics.co.za). Before gala closing date.
- Manual entries to be handed in at KZN offices before gala closing date.
- Gala entries will not be accepted from parents or individuals.
- Proof of payment must be submitted with gala entries.
- Payment reference must indicate:
  - Club Name
  - Gala number.
- Clubs Official duty form to be submitted with gala entries.
- Gala entries will not be captured if any of the above is not submitted with entries.
- Should the official's names be submitted after the closing date of entries, entries will be treated as late entries and invoiced as such?

## OFFICIALS

- All technical officials to be correctly attired.
  - White top and navy blue longs, shorts or skirts and predominantly white closed shoes.
- It is the responsibility of the CLUB to ensure that their required number of officials submitted report for duty.
- CLUBS are accountable to find a replacement if a given official does not report for duty.
- CLUBS will be fined if the required number of officials does not do duty on that day.
- Official duty roster must be submitted with gala entries, if not, then gala entries will not be captured.
- Officials are classified as Judges or Time keepers;

1 – 3	swimmers <b>no official required.</b>
4 – 10	swimmers – 1 official – 1 x timekeeper
11 – 20	swimmers – 2 officials – 2 x timekeepers
21 – 30	swimmers – 3 officials – 2 x timekeepers 1 x Judge
31 – 40	swimmers – 4 officials - 2 x timekeepers 2 x Judges
41 +	swimmers – 5 officials - 2 x timekeepers 3 x Judges.

- Officials must be qualified and registered failing which the following fines will be imposed:
  - Un Qualified R100.00
  - Un Registered R100.00
  - No Show R200.00
